A Word from the Top Dog, Bob Buckley

It was a judge, Judge Gideon Tucker, who said in 1866 that "No man's life, liberty or property is safe while the Legislature is in session." I always thought it was Will Rodgers who said it, but Google corrected me. I don't think it matters who said it. It was true 139 years ago, and it is true today. By the time you read this, the Missouri Senate will have passed its version of tort reform (what an oxymoron tort reform is!)

Most Lawyers I talk to are worried about the effect that tort law changes will have on their practices. I am frankly worried about the effect it will have on our clients and the quality of medicine in our region. The doctors are viewing the changes as a panacea for all or their financial concerns. I am sure they will want to undo all of the legislative changes when they find out in three or four years that their insurance rates did not decline.

What is amazing to me is how the doctors have allowed the insurance companies, pharmaceutical companies and other forces of darkness to use them to extract other changes in our civil justice system that have nothing to do with malpractice insurance rates. And why isn't reduction of the caps tied to reduction of malpractice insurance rates?

The next target is the nonpartisan court plan. The legislature wants to change the constitution so the Missouri Senate can approve appellate appointments. WE all need to be strong on this issue and exert whatever influence we have. In my 25 years of practicing law, we have had 12 years of Democratic Governors and 13 years of Republican Governors and frankly, I think we have an excellent court of appeals in the Western District and the best Supreme Court we have ever had. If it is not broken, why fix it? We all need to get active on this issue and try to stop the train before it leaves the station. Otherwise, it will be an expensive campaign this summer.

The legislature adjourns May 13th, which coincidentally happens to be a Friday and the date of our Steak Fry. I wish it were tomorrow. I agree with Judge Tucker.
